2014-15 Town Hall Meeting Questions

- 1. Research has demonstrated that quality family engagement in education increases student achievement, improves attendance and reduces the dropout rate. The Elementary and Secondary Education Act has been due for reauthorization since 2007. How do you feel as a state legislator you could help promote stronger school-family-community partnerships? (For our federal representatives can you respond how you would like to see parent/family engagement addressed in reauthorization?)
- 2. Addressing mental health conditions is a serious subject that many, often due to the stigma attached, feel uncomfortable discussing. Children suffering from mental health issues tend to struggle academically from the time they enter school through their secondary school years. Findings from one of the leading studies in this field, The Blind Spot by Dr. Andrea M. Spencer, found that adolescents suffering from behavioral or mental health problems were at a 51% risk for court-involvement. 82% had been suspended from school or exhibited aggressive, explosive or disruptive behavior in school. 25% suffered from depression, 20% had anxiety disorders, 17% experienced post-traumatic stress disorder, and 16% were suicidal or at risk for self-injury. "Students are often not identified for services in a timely manner, and, even when identified, access to appropriate and necessary services continues to be a problem" - Dr. Andrea Spencer. Schools play a critical role in recognizing and responding to children's mental health needs. In your role as an elected official how do you feel you can bring awareness to the issue and help bring about effective avenues to connect children with the services they need?
- 3. Public schools provide more services and resources to children and their families than in the past. Schools have been on the receiving end of budget cuts at both the state and federal level resulting in cuts that directly affect
 - students. While our state general assembly has appropriated increased funding levels over that last couple of years, our schools are still funded below 2008 levels. Underfunding has lead to inequities in school districts across the state. How do you propose we find solutions to provide our schools with the funding they need to prepare our children to be college and career ready?
- Studies have increasingly shown that voucher or tax credits have a negative impact on all public schools and fail to

Keep those donations coming! We cannot keep enough pants, shirts and coats—especially in sizes 4-16 for boys and girls. We have served over 1400 students and can barely keep enough clothes in stock. Donations can be coordinated by contacting me during the few weeks we are closed. We will be there working several Thursdays sorting, hanging and organizing.

Please check with your school nurse to see if there is a need for emergency pants at your school. I have had several requests, but we don't have any extra to give at this time. These pants can be slightly more used than what we would be able to hand out at the Clothing Bank. Small stains and imperfections are ok. These pants are used when students have an accident or spill and just need something to get them through the day. Sizes 5-10 with elastic waist are best.

Please don't forget to send volunteers as often as you can. We typically see a decline in volunteers after we open again in January, and there is still lots of work to be done. Thank you for your partnership and help keeping our SPS students in good, clean clothes to ensure a successful education.



produce benefits they claim. They do not ensure parental choice, protect the civil rights of students, increase student's achievements, help low-income students, or improve public schools by creating an environment of competition. Missouri PTA believes every student should be provided with a quality education. This cannot be accomplished by

handing out vouchers or credits to a few. Instead we must collectively invest in our public school system where the overwhelming majority of children are educated. What is your position on tax credits, vouchers, or income tax deductions for tuition paid by parent or sponsors for nonpublic elementary and secondary school children?

From the Parliamentarian

It is not too early to start thinking about THE NOMINATING COMMITTEE

The nominating committee is the most responsible and sensitive deliberate body of any PTA. It should be undertaken with great care. Check your PTA's bylaws for details.

The nominating committee must be **ELECTED**. This is usually by the general membership as listed in the PTA bylaws, in the article titled "Officers."

The number of members is very specific, and no one (not even the principal) is automatically on the committee, except as a non-voting adviser if the bylaws so specify. **The president cannot be on this committee.**

The chairman is either appointed by the president or elected from the committee; again, check the bylaws.

Major Saver Fundraiser

Hello, my name is Jennifer Penny, and I am your VP of Organization & Development for SCPTA. I am in charge of the annual, joint fundraiser with local schools, PTA/PTSA units and SCPTA. I am very pleased to announce that we have partnered with Major Saver to offer discount cards for offers to local restaurants and family activity businesses!

SCPTA is very excited about the Major Saver (MS) program. They offer a 100% turnkey program and manage everything from kick-off to final payment. Here are some of the details about the fundraiser:

- The MS discount card is customized for our community and includes business from all over Springfield, which we know is important to all of you.

- Council will receive daily updates about the fundraiser.
- Payment will be paid no later than 30 days after the close of the campaign!
- The card will include two detachable key fobs with additional offers.
- NEW THIS YEAR--Cards will also be available via the new MS App!
- MS will handle the entire collection and prize distribution process
- MS assumes all responsibility for the collections on NSF checks—school sales will not be affected
- MS has listened to feedback from our principals and knows the limo ride is an important incentive, so students only have to sell 10 cards to win the limo ride.

This fundraiser is the ONE AND ONLY means the Council has to fund ALL of the projects and programs that we all—presidents, principals, officers and volunteers—decided were important to us, as a Council, all those years ago.
