Letter From the President-Carrie Windes

PTA/PTSA Presidents, Officers and SPS Administrators:

As the school year comes to a close, I want to thank all of you who have represented your units and congratulate you on a job well done. Before you deem the school year over, remember to wrap up your units in a way that will help the new officers when the next school year rolls around. Here are some tips to help make a smooth transition for your officers, so the children are the ultimate beneficiary.

Have all of your officers meet with the new officers as a group and then individually. Discuss the past years' successes and failures and the coming years' objectives.

Personally introduce the new officers to Principals, teachers, community leaders and other PTA contributors.

Have your officers complete their procedure books then pass them on to the new officers. Make sure all passwords and account information changes hands as well.

The treasurer should pay all the bills, settle all accounts, and be sure records are ready for the financial review.

A financial review committee should be appointed and prepare to review the treasurer's books in a timely fashion.

If the PTA bylaws were reviewed or amended make sure to send two copies to the Missouri PTA State office.

Make sure you've sent the names, addresses and other pertinent information to MOPTA too. This needs to be done even if your officers are staying in their positions.

Signatures on the PTA bank accounts should be changed to the new treasurer, secretary, and president if needed. (Remember that all checks should be signed by two people.)

The new officers should be installed, and outgoing or retiring leaders should be thanked for their service.

The most important tip is to attend the SCPTA School of Information or one of the MOPTA training sessions! There are also e-learning courses at ptatraining@pta.org.

PTA/PTSA leaders that take care of these tasks will find it easier to provide exciting and effective activities and programs next year that will engage and serve your members and the children.

As the school year is close to an end, so is my term as your president of SCPTAs. I would like to thank everyone who has served and worked with our PTA/PTSA units these past two years. I'd like to say a special Thank You to the SCPTA Executive Board who made my job much easier. It's been my honor to serve the children of Springfield with all of you. Thank you and have a great summer!

I'm so grateful to our community for allowing me to attend the SCPTA State Convention in Columbia, MO this year. This was my first PTA convention and was extremely impressed with the amount of information available to all of us. I encourage anyone that can attend a convention like this to do so.

The convention schedule offered a General Meeting, Exhibit Hall, Training Sessions, and Roundtable Networking. The General Meeting, was attended by our Springfield delegation. This meeting included the annual report from Missouri PTA President, Dorothy Gardner, greetings from our National PTA Secretary/Treasurer, Wayne Bauman, and then a presentation of all the awards earned this year.

Next were the 30 workshops offered throughout the weekend that we were available to selected from. My first workshop was on Leadership Awards given by Sarah Day, PTA VP, which showed how PTA member can qualify and apply for the awards. They have revised and revamped all the Membership awards to simplify the process with the application and due dates. Next was Retaining Today's PTA Members, given by Wayne Bauman, Secretary/Treasurer National PTA. Using this proven renewal process model to keeps those members engaged and connected throughout the school year, leading to increased retention rates in your schools. Another attended workshop was Reflections, given by Susan Rupert, Missouri PTA President Elect. Family Reading Program is a National Program that was developed to engage the whole family with interactive reading activities. This program is an event that could be held a couple of times a year, promoting families to engage at the elementary level.

It was my pleasure to attend the Missouri PTA 101st Annual State Convention April 29-30 in Columbia, Missouri with my daughter Mattie James who is a freshman at Glendale. She was one of 7 students attending the convention. This was my first PTA convention and it was an eye opening experience. Saturday morning began with workshops. I attended Missouri's Budget Challenges workshop presented by Mike Sutherland which focused on the Missouri State Budget and revenue outlook for FY 2018, the impact on education funding and potential revenue policy solutions. The second morning workshop I attended was by Wayne Bauman entitled Retaining Today's PTA Members. We learned how important the renewal process is as well as engaging members and staying connected with them throughout the year.

Our delegation then attended the General Meeting & Awards Presentations. Every unit and council is required to hold an annual meeting and so is Missouri PTA. During this time they conduct the business that must be accomplished before the general membership. Additionally we heard from a guest speaker, National PTA Secretary, Treasurer, Wayne Bauman who is the National PTA Secretary/Treasurer and awards were presented. After the working lunch I attended a workshop by Bonnie Cannon called Conflict Management and finished up the day with an extremely informative workshop by Carla Weise entitled Legislation, Advocacy & PTA where I learned the background on the Radicalization of Youth Resolution that was passed during the General Meeting.

I attended two workshops on Sunday. The first was a Fundraising Panel presented by SparkI W. and Andrea B. where I learned what has been successful for other PTAs and what hasn't worked. The second was Social Media II - Intermediate through Advanced that discussed ways to expand our reach and effectively communicate our message while building our image on social media which was amazing!

My biggest take away was learning that PTA is truly about child advocacy and that no other child advocacy organization does what we do with a focus on EveryChild OneVoice. As the Missouri PTA President Dorothy Gardner stated, we DO make a difference.

I was honored to attend the 101St Missouri State PTA Convention in Columbia, MO during April 29-30, 2017. I attended 7 workshops and look forward to sharing information from these workshops with anyone who is interested. MO State PTA plans to add the slide presentations from all the workshops to the state website soon. Other online resources were available now.

Membership Basics by Christine Kent, MO PTA VP and Director of Membership Services reminded us that the PTA vision is to "make every child's potential a reality" and reported that next year's membership theme would be "Memberships are within our reach." Issues were raised about the challenges of membership as schools move to no-paper, electronic registrations and communications. Resources are available at https://mopta.org/membership-basics/. The second workshop was No Carrot, No Stick: Emergency Operations Planning and presented by John Warner, Emergency Planning Coordinator with Missouri School Board Association's (MSBA) Missouri Center for Education Safety (CES). PTAs were advised to think beyond active-shooter planning and to make sure our schools have and that PTAs are aware of how parents fit into expanded All-Hazard approach emergency response plans. Resources are available at http://www.msbanet.org/msba-center-for-education-safety/. The third workshop I attended was Missouri's Bully Law by Scott Summers, JD and Director of School Laws for MSBA. Mr. Summers is an attorney and discussed MO 160.775 which amends Missouri's definition of bullying, MO 170.048 which now requires districts to have a Youth Suicide Prevention policy, and the federal replacement of No Child Left Behind with Every Student Succeeds Act (ESSA) Mr. Summer also discussed how these laws apply to Cyberbullying. The fourth workshop was Treasurer I by Sonia Smith, MO PTA State Treasurer who provided a monthly timeline of the responsibilities of Treasurers, discussed the importance of units being in Good Standing, and recommended units have insurance and bonding. She also reminded us of the 3-TO-1 rule which says PTA do 3 non-fundraising activities for every 1 fundraising activity. She cautioned units not to violate the Sunshine Funds rule which says units cannot use PTA funds to benefit any individual person or family even after catastrophic events like fire or floods. Online training for Treasurers is available at https://member.pta.org/Shop/Local-Leader-eLearning-Courses. The fifth workshop was Legislation, Advocacy & PTA by Carla Wiese, MO PTA VP & Director of Legislation and Advocacy who reminded us that as PTAs we "speak for every child". We learned of a dangerous substance called "Powered Alcohol" that just looks like pixie stick candy but is actually ethyl alcohol encased in sugar and extremely dangerous. Powered alcohol is the focus of current MO legislation HB 29, https://mopta.org/advocacy/action-alerts/jcdc-action-alert-hb-29-powdered-alcohol/. Members can register for legislative updates called JC/DC by subscribing to newsletter on MOPTA website and checking the JC/DC box. The sixth workshop was Engaging at Risk Youth & Their Families by Kristina Wilmouth of Springfield and MO PTA Public Relations Chair and by Angie Warner, MO PTA Regional Director. PTAs were reminded to Reach Out, Reach Often, Reach Further to be there for every child. At-risk youth are found in all walks of life, and one positive experience can impact and support a child's successful development. The seventh workshop was Diversity & Inclusion by Burchell McGhee, MO PTA Diversity Outreach & Engagement Chair. PTAs must work for diversity at all levels of participation in our mission to serve every child. The PTAs Values which include Diversity are available at http://www.pta.org/about/content.cfm?ItemNumber=944&navItemNumber=552.

I felt it was perfect that the final workshop reminded us that PTA's mission is to make every child's potential a reality by engaging and empowering families and communities to advocate for all children.

The winner, Daniel Gutierrez, vocal music teacher at Reed MS, was announced at the Teacher Appreciation Banquet, which I attended on the 17th. Helped with May's newsletter. Emailed Presidents and Board regarding our council SCPTA. We changed date from May 2nd to May 16.

The May general meeting will be held May 3rd at the Sherwood Elementary Project Lab. This final meeting of the school year is hosted by the SCPTA council. Major Saver participation checks and fundraiser checks, Major Saver's check to Clothing Bank, membership award certificates, and attendance incentive checks will be passed out. We will also vote on the proposed budget for next year and install next years' officers. The SCPTA School of Information will be held at Parkview High School on Tuesday, May 16, from 5:30 to 8:30 p.m There will be an SCPC meeting on the 18th.

Legislative Chair - Donna Petiford

Our council legislative goals this school year were to include a Legislative Q&A with our local elected officials and a school board candidates' forum. Due to the elections, we chose not to host the annual Legislative Q&A, but we continued to inform members about legislative actions in Jefferson City and Washington DC and encouraged voter registration and voter turnout throughout the legislative session. We did not host a school board candidates' forum because there was not a school board election this year. Instead we hosted a Q&A with school board member Gerry Lee and SPS officials regarding the bond proposal.

Council passed the resolution "Supporting the April 4, 2017, Bond Initiative" and helped educate and inform members about the proposed \$189 million bond. Although the bond proposal did not pass, we are committed to continue working with the district and the community to ensure equity and opportunity for all students.

National PTA was encouraged by the US House of Representatives' passing the "Supporting Youth Opportunity and Preventing Delinguency Act", which would reauthorize the Juvenile Justice and Delinguency Prevention Act (JJDPA) and strengthen the nation's juvenile justice system. Reauthorization of the JJDPA is long overdue. National PTA continues to work for US Senate passage of this bill.

Missouri PTA continues to work to defeat MO Senate Bill 32 which would establish the Missouri Empowerment Scholarship Accounts Program. Missouri PTA opposes diverting public funds to private and parochial schools through vouchers or other measures. Missouri PTA issued a number of legislative alerts throughout the session and gave testimony in Jefferson City on issues of child protection, juvenile justice and support of public education and education funding.

Vice President: Organization and Development -- Julia Stalder

Handbook Continuing the change made last year, the handbook is posted in an electronic format on the SCPTA website.

Bylaws All schools who had bylaw revisions coming up were notified and offered assistance as needed, state office information on bylaw renewals was reviewed, and those schools who did not have their bylaws renewed were contacted to let them know that they were not a unit.

Gertrude McBride Fund: Springfield Council of PTAs awarded high schools and middle schools each from the Gertrude McBride Fund. This fund was established in 1921 to honor Gertrude McBride, an educator, school board President, and a founding member of our local PTA. CARE Fund: Twelve elementary schools were awarded, each to recognize outstanding student behavior, attendance, and academic achievement. This fund was established in 2004 to honor Charlie Nickel, a longtime Springfield educator and PTA supporter. Bingham, Bissett, Boyd, Delaware, Disney, Harrison, Pershing, Pleasant View, Rountree, Sherwood, Watkins and Wilder. This spring, the 5 high school scholarships for the 2016-17 academic year will be awarded. Each scholarship will be \$500 and is nonrenewable. Proof of enrollment must be submitted to SCPTAs by September 2016.

Resource Development: Thirteen schools participated in the Major Saver discount card fundraiser and combined they raised more than \$47,500. The 13 schools' principals will receive \$200 from SCPTA each as incentive for participating in the fundraiser and the school that sold the most cards will receive a \$500 check for their school site. In addition to the money raised from card sales, Major Saver is donating \$200 to the Clothing Bank for every school that participated: Bissett E. Disney E. Mann E. Jeffries E. Twain, E. Pershing E, Pershing MS, Pleasant View E, Pleasant View MS, Portland E, Gray E, Wilson's Creek 5-6, and York E.

Historian's Report 2016 - 2017

Vice President: Promotions -- Carrie Windes served

Membership Council had a total of 4,480 PTA/PTSA Memberships reported to State for the 2016-17 year. The SCPTA held 2 different membership challenges this school year. A drawing was held for \$75 for units who had an increase in individual memberships and another drawing for \$75 for units with an increase in business memberships was held. The winter challenge was to increase membership between January 1 and March 15. Those units with an increase qualified for a drawing for \$75.

Founders' Day "PTA: Your Adventure" was the theme for Founders Day! The event was hosted by Glendale High School on Thursday, February 23rd, at Glendale High School. Mark Miller, OTC Director of Communications and Marketing and a Glendale dad, was our emcee. The Glendale Girls Service Society were our servers for the evening. The Perfect Fourths, Glendale string quartet played prior to and during dinner. SPS Nutrition Services provided a delicious buffet including BBQ brisket, chicken, mashed potatoes, macaroni and cheese, apple and peach cobbler with vanilla ice cream. Our MOPTA President, Dorothy Gardner, was the guest speaker and told us a story about Blueberries! PTA: Your Adventure, a student-produced video, made us laugh and cry! Students from Glendale feeder elementary and middle schools, and a Glendale junior each expressed what PTA has done for them and their school. We had 30 schools represented and a total of 37 Volunteers of the Year. The volunteers' names, photos, and a quote by each explaining how PTA has been an adventure for him or her was incorporated into a student-produced slideshow. Each volunteer was awarded a certificate by Dr. Jungmann and a gift from Council. We also presented a red rose to each of our four past council presidents in attendance. Patty Dunn was presented the MOPTA Distinguished Service Award. The photo booth with our roaring campfire was a big hit, and volunteers left with several special treats from our host, Glendale High School, including plants from Glendale's Green Squad and bark candy from Glendale's Culinary Team.

The SCPTA purchased 2 cases of Apples from Kiwanis in the fall to show appreciation to the KAC Administrative staff. Helped with food selection and setup for the Founder's Day Banquet at Glendale. Will provide refreshments for our May general council meeting. Will provide food/drinks/door prizes for the School of Information Training on May 16 at Parkview. Coordinated with the Host Schools each month in preparing for our monthly council meeting.

Clothing Bank The SCPTA Clothing Bank had a fabulously productive year and served over 130 more kiddos this year than last. We were blessed with volunteers and donations. We had 3 regular volunteers we depended on in Jody Schaad, Janetta Tracy and Terry Dunham and the feeder pattern schools really showed up to help sort and serve our children. We also benefitted from churches, service societies, Greenwood parents and children, Drury students and the MSU Fashion Design and Merchandising department. Other friends who we depended on were Julie Baker, Carrie Windes, and Tom Wyrick. We also had our own little Clothing Bank Angel named Kathryn Wilkerson who was our personal, professional shopper and showed up almost weekly with whatever we needed.

The SCPTA Council donates \$7,500 to the clothing bank each year, Major Savers donated \$2,600 and we had a \$1000 anonymous donation. We would also like to thank these schools for their financial donation: Wanda Gray, Harrison, Sunshine, Pleasant View, Sherwood, Truman, Glendale, Cherokee, Wider and Horace Mann. The Clothing Bank received a \$500 Grant from YEP (an initiative of Community Foundation of the Ozarks), coats from the Salvation Army again this year and school supplies and coats from the Kitchen. SPS continues to support our mission and provided us with new computers and a panic button for emergencies. Principal Justin Dickenson, Miss Vickie, and the Study Staff have all been very supportive.

The Clothing Bank had over 2,029 visits (39 days open) and we sent our shoppers out with 8,001 tops, 4,772 bottoms, 1,294 jackets, 493 coats, 6,426 pairs of undies, and 6,453 pairs of socks. The Kiwanis Club put shoes on 1,105 children. Jennifer Penny was the VP on the Council, Patty Dunn was the Clothing Bank chair and the two worked together as co-chairs. We were blessed with the arrival of Allison Lawson who accepted the VP position for next year and started volunteering regularly in February and has really stepped up to learn the ins and outs and brings fresh energy to our Clothing Bank. We would like to thank the Missouri Council of the Blind for picking up the clothing we couldn't use every Thursday like clockwork.

It will be an evening training session from 5:30 to 8:30 p.m. with workshops for President, Treasurer, Secretary, Parliamentarian, Membership, Fundraising, Reflections and more.
