These legislative priorities are based on the issues that the Missouri PTA Legislative Department expects to target for the 2016 legislative session. As unexpected issues emerge, Missouri PTA will act in accordance with the resolution and position statements that have been approved by the membership. A complete list of resolutions and position statements are available on our website (www.mopta.org). Missouri PTA supports:

Legislation that protects and calls for local control of schools.

Legislation to strengthen laws designed to protect minors from abuse and increase funding for programs and services aimed at the prevention of child abuse, neglect and maltreatment.

Legislation that supports increased access to mental health services for children.

Opposition to tax credits or tax deductions for tuition paid by a parent or sponsors for non-public elementary or secondary school children.

Enforcement of legislation requiring school districts to have policies that promote increased parental engagement in their children's education.

Legislation that will maintain or generate local and state funding for public education.

Legislation that will safeguard the educational and personal records of students.

Is your PTA/PTSA "In Good Standing"?

One of the most important things we do as a Council is to ensure that every PTA or PTSA member stays in good standing with the state and national PTA in order to participate in the programs and benefits offered by the association. A PTA unit is "in good standing" if it:

- Adheres to the purposes and basic policies of Missouri PTA (MOPTA);
- Remits national and state dues to MOPTA by date required;
- Has bylaws approved every three years according to the procedures of MOPTA;
- Submits a copy of the unit's fiscal year-end report to MOPTA by December 1st of each year;
- Submits a copy of the unit's annual financial review to MOPTA by December 1st of each year;
- Submits a copy of the required IRS tax form to the MOPTA by December 1st of each year;
- Submits the names and addresses of officers to the MOPTA by March 31st of each year; and
- Meets other criteria as may be prescribed by MOPTA.

These are minimal requirements of Missouri PTA and also help uphold the integrity of the business of your PTA/PTSA as well as fulfill IRS guidelines to maintain your PTA/PTSA's 501(c)3 status with the IRS.

In addition to these minimal requirements of Missouri PTA, Springfield Council of PTAs requires unit council dues (\$35) to be paid by November 1 of each calendar year (\$45 if paid after November 1).

If a local PTA becomes "not in good standing," as soon as it has fulfilled the necessary requirements, it is again considered "in good standing."


Tips for Treasurers



Parliamentary Tip of the Month

What is advocacy?

PTA® defines advocacy as supporting and speaking up for children—in schools, in communities, and before legislative bodies and other organizations that make decisions affecting children.

What an advocate does

A child advocate works with policy makers (at the federal, state, and local levels) to ensure sound policies that promote the health and well-being of all children.

Communicating With Elected Officials

There are several ways that PTA recommends you can connect with your elected officials. First and foremost, know who they are and how to reach them. Keep a list of all of your state and federal representatives and senators handy so that as issues arise, you are ready to connect. Emails, phone calls and personal visits are among the best and most effective means of communicating with these decision makers. Emails are easy and effective, while phone calls are especially efficient when an important vote is coming up. By far, the most impressive communication is a personal visit, not only does this make the message personal, it helps build relationships and establishes you as someone who can be a resource to that member of congress or the state legislature on issues important to children.

Keep in mind these tips when contacting elected officials:

E-Mail

Emails should contain the basics of effective, professional letter writing. Do not use abbreviations, trendy letter combinations or symbols to make your message heard. Have another person proofread your letter before you send it. Use spell check if available, and copy others that need or want to be kept informed of the situation. If a legislator wants to print your email, you want a document that will get the respect it deserves. National PTA will provide a template letter with requests for action, however, it is important that you personalize these letters so that your audience knows where you stand on the issue and why this is important to you. (I've been told by my representative that he can spot a form letter, so the more you can make the template sound like you-the better). *Anonymous communications are not read so don't forget to include your name and title, address, phone number and email address on all communication.*

Phone Calls

Before you place your call, remember that it is not the member of Congress themselves answering the phone; it will most likely be a legislative staff member with whom you speak. Make sure to prepare beforehand for your call. Make notes of particular legislation and research for each issue. Identify yourself as one of the member's constituents and explain to the staff member what it is you are calling about and what action you would like to see taken.

Personal Visits

Meeting in person to discuss a particular bill or issue is the BEST way to influence your legislator. Prepare for your visit beforehand, make an appointment ahead of time and arrive promptly. Always be respectful in your tone and language and present yourself in a professional manner.

Whether your communication is by email, phone or in person, always be polite, courteous and concise. Take time to thank these public servants for their service to your community and try to illustrate the connection between the legislation being voted on in Washington or Jefferson City with the effects it will have locally. This will help bring the point home to the member and provide further encouragement for their office to take your requests and concerns seriously. Remember, they were elected by a vote of the people and are where they are to represent you. If presented well, you will find that these elected officials will welcome your advice.

LEGISLATIVE FOCUS

Investing in Missouri: Creating a Better Future for Our Families

An abundance of research indicates that quality early learning programs are critical to creating a foundation upon which all children can thrive. High-quality early care and education fosters the development of the cognitive and social skills that are central for children to succeed in school and life. Studies show that children who receive quality early education do better in school, have higher incomes and improved health outcomes as adults compared to their peers. Studies also indicate that public investments in preschool and other early learning initiatives provide a significant return to taxpayers, resulting in as much as a \$7 return for every \$1 invested due to decreased public expense for remedial education, criminal justice and social services. "Invest in Early Childhood Development: Reduce Deficits, Strengthen the Economy", and "Four Big Benefits of Investing in Early Childhood Development," both by James J. Investing in Missouri: Investing in our Students' Futures

In the current school year, the amount of funding provided through Missouri's "Foundation Formula", which distributes state support to local schools, remains \$400 million under the statutorily required level.

Had state funding increased at the same rate as inflation between the 2001 and 2014 school years, state funding would have been \$361 million greater in FY 2014. That's the equivalent of our local schools having an additional \$554 per student to enhance educational opportunities.

All of Missouri's children deserve an opportunity to thrive. A solid education is a fundamental building block to a better future. We can – and must – do better by fully funding our local schools. **Missouri Budget Project**

Each child gets to express their individual "style" by picking out their own hand-fitted shoes. During this last school year, the Kiwanis Shoe Bank hand fitted over 1,100 pairs of new shoes. That brings the grand total, since 1950, to over 30,000 pairs of free shoes!
