

# **Tips for Treasurers**

• When receiving money for membership dues and fundraiser sales, be sure to deposit cash and checks immediately into your PTA/PTSA account. Cash counting sheets are available from your SCPTA treasurer, or make your own. Two people should count and sign and date the sheet. Be sure to make notes identifying all deposits and expenses, including what monies are from fundraiser item sales and what monies are from memberships, or donations. Copies of deposit/cash sheets from each event should be given to the Chairman and the Treasurer.



Keep a spreadsheet of your memberships noting name, amount received, date received and the date you sent state and national portions to MO PTA. Forms are available at <a href="http://mopta.org/wp-content/uploads/2007/08/2015-2016MembershipDuesForm.pdf">http://mopta.org/wp-content/uploads/2007/08/2015-2016MembershipDuesForm.pdf</a> or by emailing <a href="mailto:rsvolz5@gmail.com">rsvolz5@gmail.com</a>. The portion of unit dues for the state are requested at the beginning of each month.

Detailed financial records are available on-line at http://www.nonprofitcentral.biz. Use SCPTA as the username and password.

We continue to send weekly text blasts to remind schools of their assigned day at the Clothing Bank, and we have been met with an incredible response! Every week we get to see old friends of the Clothing Bank and make new ones from nearly every school in the district. Our volunteers are the heart of the organization and their willingness to serve is invaluable and inspiring! Again this year after the *Trading Hands* Kids Consignment Sale ended, Jennifer Shotwell with Delaware PTA loaded up her truck and brought us tons and tons of beautiful children's clothes! Later that day, we had a huge group of volunteer moms and dads from Hickory Hills work alongside us to get the entire donation out on the floor for our customers!

They collected 20 boxes of clothing for us earlier in the school year—only to top that with a recent all-school clothing drive that literally filled half of our donation/sorting room! Commerce Bank employee and friend-of-the-Clothing Bank, Whitney, organized a coat drive and cash donation drive. Commerce raised over \$1600 and donated over 50 winter coats! Not only did they personally come by to deliver the check and coats, but three bank employees stayed a while to volunteer! Amazing!!

And last but certainly not least, as part of a PBL unit on citizenship, students in four classrooms at Hickory

Hills looked for an opportunity to help kids in their own community—and they chose to help kids through the Clothing Bank! For a few weeks they worked hard to recruit volunteers, gather clothing donations, and hold a bake sale to raise money for the PTA Clothing Bank. The students were in charge of planning, organizing, and communicating their project to the community. Their efforts paid off as they raised \$648.75 from their bake sale, recruited over 15 volunteers, and collected several boxes of clothing. Their teachers said the students "were beyond thrilled to help an organization that provides so much for kids that are in need in their community." # Parliamentary Tip of the Month

Parliamentary procedure requires that all members have equal rights; that there be mutual respect among board members; that the rights of the minority to initiate motions, debate, and have their votes counted be protected, while at the same time the will of the majority governs.

Only one item may be under consideration at a time.

The majority vote decides the question.

The simplest, clearest, most expeditious way to conduct business is considered proper, as long as it does not violate the rights of members.

#### RESPONSIBILITIES OF BOARDS

Assure that all business is conducted in accordance with the purpose and bylaws of the organization.

Assure that only those individuals who are properly authorized speak, correspond, or otherwise act for the entire organization.

Assure that all members are aware of the organization's purpose and are trained in its procedures.

Assure that all business is conducted in a manner that preserves the organization's tax-exempt status.

Assure that all funds are handled in a responsible manner and disbursed in accordance with the budget and other guidelines

Assure that income is adequate to maintain the organization's activities and programs.

Assure that membership practices comply with state and federal requirements.

Assure that all records are maintained and retained and that property and equipment is maintained properly.

#### RESPONSIBILITIES OF INDIVIDUAL BOARD MEMBERS

Attend all meetings at which business is discussed.

Be familiar with and review bylaws, financial statements and other significant documents.

Know how meetings should be conducted – know your parliamentary procedure.

Keep good records.

Insist any activities shaving legal ramifications be reviewed by counsel.

Speak and act only with authority granted or delegated.

Communicate and act through proper channels.

#### FREQUENTLY ASKED QUESTIONS

#### Can bylaws be suspended?

Only bylaws that are clearly in the nature of rules of order (for a business meeting) may be suspended. This can be done with a two-thirds vote. For more information, refer to Roberts Rules of Order Newly Revised 11th Edition (RONR).

#### President has resigned, now what?

Most PTA bylaws have a provision in Article VI Section 9 that an election will occur to fill the unexpired term of any officer that resigns and that, in the event of the President's resignation, the Vice-President will serve the notice of election. In the interim, the Vice-President will act as president until the election occurs. This is different from RONR in which case your PTA bylaws supersede RONR.

#### When does a resignation take effect?

A resignation is actually a request to be excused from a duty. It is effective only after the resignation has been accepted by the appointing or electing authority, un-less the by-laws say otherwise.

#### Are mail-in, email or telephone okay?

No, not unless authorized by the bylaws. If allowed per bylaws, a provision should be included that states that the result of such votes will be noted in the minutes of the next meeting.

#### Does a treasurer's report need to have a motion of approval?

No, a motion is not needed nor is it proper. A treasurer's report is simply "received" as it is given and no motion should be made to "adopt", "accept" or "approve" it. An annual auditors' report, on the other hand, is 'accepted" or adopted.




#### 2015 Hall of Fame inductees named
