Missouri PTA Legislative Platform 2014

These legislative priorities are based on the issues that the Missouri PTA Legislative Department expects to target for the 2014 legislative session. As unexpected issues emerge, Missouri PTA will act in accordance with the resolution and position statements that have been approved by the membership. A complete list of resolutions and position statements are available on our website (www.mopta.org). Missouri PTA supports:

- Legislation that protects and calls for local control of schools.
- Legislation to strengthen laws designed to protect minors from abuse and increase funding for programs and services aimed at the prevention of child abuse, neglect and maltreatment.
- Legislation that supports increased access to mental health services for children.
- Legislation that provides funding for early education programs that are developmentally appropriate, coordinate comprehensive services, and includes family engagement components for children from birth to age five.
- Opposition to tax credits or tax deductions for tuition paid by a parent or sponsors for non-public elementary or secondary school children.
- Enforcement of legislation requiring school districts to have policies that promote increased parental engagement in their children's education.
- Legislation that will maintain or generate local and state funding for public education.

ALL units are required to file a tax return with IRS by November 15, 2013 for the tax year 2012 (2012-2013 school years). File a 990-N (electronically) if gross receipts are less than \$50,000. File a 990-EZ and a Schedule A if gross receipts are more than \$50,000.

The following documents are due to Missouri PTA on December 1, 2013:

- Year-End Financial Reports
- ① Copy of Annual Financial Review (audit)
- ① Copy of IRS Form 990-N or 990-EZ

Missouri PTA must receive these documents for your unit to be a "Unit in Good Standing". Your unit must be in good standing to participate in Reflections and Membership Awards.

Basic Principles of Parliamentary Procedure

Every member has rights equal to every other member.

The will of the majority must be carried out, and the rights of the minority must be preserved. The minority has the right to be heard, but once a decision has been reached by a majority of the members present and voting, the minority must then respect and abide by the decision.

A quorum must be present to do business—this number is usually stated in the bylaws.

Silence is consent—those members who do not vote agree to go along with the decision of the majority by their silence.

Personal remarks in debate are always out of order-the presiding officer must rule all personal remarks out of order.

Debate must be directed to motions and not motives; principals and not personalities.

The Nominating Committee

The nominating committee is an elected committee designated with the task of finding the best possible candidate for each officer position. Once the committee has made their selections, a report is submitted to the membership body and an election for officers is held.

Check your unit's bylaws under the article entitled "Officers". The bylaws will outline any specific criteria for the formation of the committee, including a stipulation that (#) the nominating committee shall be elected.

The nominating committee should include experienced and newer members of the unit selected on the basis of their merit and ability, their knowledge of PTA goals, purposes and programs, and their ability to keep deliberations confidential.

The current president cannot serve as a member of the nominating committee and is not on the committee ex officio. However, the president should make sure the committee has a copy of the unit's bylaws, membership lists, realistic descriptions of the duties for each office and a nominating committee procedure guide.


PTA Family Reading Experience

PTAs can use resources and promotional tools to organize a series of events that will engage the entire family and focus on improving reading skills between kindergarten and fifth grade—which would reinforce a year-round commitment to family reading. The curriculum, which National PTA developed in consultation with family engagement and literacy experts, includes activities with both physical books and e-books. The program brings together all five domains of reading including: phonological awareness, phonics, fluency, comprehension, vocabulary.



During this last school year, the Kiwanis Shoe Bank hand-fitted over 1,100 pairs of new shoes bringing the total number of new shoes given to Springfield school children since 1950 to over 26,000!
