Updated as follows: On Nov 27th the board of education voted to put a 168 million dollar bond issue on the ballot for April 2nd. It will reflect projects of new construction, renovations and secure entrances. The Community task force recommended these projects for the board to vote on. The Board approved these recommendations. New construction: Delaware Elementary, Boyd,(midtown,still trying to figure out a property) Jarrett,(a new southwest early childhood center,possibly on Carver property); Major renovations: Hillcrest, Sunshine and Williams(also expanded space for early childhood); 31 sites will get secure entrances; Central(2), Parkview(1), k-8: Pleasant View, Pershing;Carver, Jarrett, Pipkin, Reed; Wilson's Creek; Bingham, Bissett, Cowden,Disney, Field, Holland, Mann, McBride, McGregor, Pittman, Robberson, Truman, Twain, Watkins,Weller, Wilder, York ; Looking for substitute teachers, bus drivers, nutrition services; go to [sps.org](http://sps.org), to learn more; Sign up for Winter school cancellation notifications on the sps website, or check on social media, television.
